



Physical Damage Loans



Loan Terms:

- Up to 30 years, based on ability to repay
- Low-Fixed interest rates **4%** for businesses, **3.25%** for private nonprofit organizations and **2.813%** for homeowners and renters
- No monthly payments or interest for the first year
- Physical Loan Application Deadline Date: 11/29/2024 (Helene)
- Physical Loan Application Deadline Date: 11/25/2024 (Debby)



These loans cover disaster losses not fully covered by insurance or other sources. Proceeds from insurance coverage may be deducted from the eligible loan amount.



Homeowners, Renters, Small businesses and private nonprofit organizations.



Maximum loans \$500,000 for Homeowners

Maximum loan \$2,000,000 for businesses and non-profits



Renters and homeowners may borrow up to \$100,000 to replace or repair personal property (clothing, furniture, cars) damaged or destroyed in a disaster.



You may be eligible for up to a **20% loan amount increase** above the real estate damage, as verified by SBA, for improvements to help prevent risk of future damages.



Economic Injury Disaster Loans (EIDLs)



Loan Terms:

- Up to 30 years, based on ability to repay
- Low-Fixed interest rates 4% for businesses, 3.25% for private nonprofit organizations
- No monthly payments or interest for the first year
- (EIDL) Loan Application Deadline Date: 6/30/2025 (Helene)
- (EIDL) Loan Application Deadline Date: 6/24/2025 (Debby)



Working capital loans for small businesses and private non-profit organizations that sustained severe economic impact as a direct result in this incident.



EIDL assistance is available regardless of whether the business suffered any physical property damage.



Maximum loan amount is \$2,000,000



Help meet working capital needs caused by the natural disaster (flooding in this case) and help the local economy.



EIDLs do not replace lost revenue, lost profits or fund expansion



Requirements for Loan Approvals



Eligibility

• Damaged property must be in a declared area.



Credit History

• Applicants must have a credit history acceptable to SBA.



Repayment

• Applicants must show the ability to repay all loans.

Collateral Requirements

- Disaster loans in a Presidential Declaration over \$50,000 require collateral
 - o SBA takes real estate as collateral when it is available.
 - SBA will not decline a loan for lack of collateral but will require the borrower to pledge collateral that is available.
 - o Collateral requirements for Physical and Economic Injury Disaster Loans are separate. Depending on the loan amount for each category, a **business** may receive **up to \$100,000** on an unsecured basis.





What documentation is needed when you visit the SBA Center to apply for a disaster Loan?

- Cell Phone Number & Contact Information for all applicants
- Proof of residence in the disaster area declared
- Social Security Numbers and Employer ID Numbers (EIN) for all owners
- Financial Information: income, account balances, monthly expenses, etc.
- Complete copy of the most recent Federal Income Tax Return
- Insurance Information, if available






How to Apply

Disaster Declaration Search

Step 1: Visit https://Lending.sba.gov/ and select Determine your eligibility

Step 2: Select your State and County





Tips if you apply online



- Legal name, ID, etc. as appears on the federal tax filing
- Multiple Log In Attempts
- Password Reset (Photo of Username and password)
- Multiple owners Joint application
- Notifications How to ensure you stay in the know
 - Monitor the Portal and your email every day
 - Check your Spam folder

Targeted Recovery Campaigns

To assist businesses with short, intermediate, and long-term recovery efforts, FOCE will implement targeted campaigns designed to: assist owners in receiving favorable outcomes, message the services available to the community, and promote long term recovery and resiliency.

Business Reconsideration

An analysis of the demographics, within the primary counties, businesses in the impacted areas. FOCE anticipates starting the reconsideration campaign <u>within 2 weeks</u> of the declaration notice. Targeted audience will be businesses that fell **2-points** short of the SBA credit threshold and were auto-declined.

Business Withdrawal

FOCE will use its internal assets to assist businesses that were withdrawn due to missing or incomplete documentation. In cases where the business structure is **more complex**, FOCE will look to leverage the assistance of resource partners to assist with these files.

Targeted EIDL

FOCE will execute a robust EIDL campaign targeting small businesses in the primary and contiguous counties, including entities in the rural and underserved communities <u>30 days before the physical filing deadline</u>. We will leverage the communications networks of partners for publicity and collaborate on EIDL workshops in the impacted counties.

Targeted Business Analysis

FOCE will leverage the available resource partners to provide training, technical and financial assistance, and counseling services to <u>approved</u> <u>and declined businesses</u>. Our data analysis will take place at the end of the physical filing deadline to determine our targeted audience.
